Bid opening shall be opened in the presence of Bidders representatives who choose to attend on 12-02-2020 at the office of Chandrakot Rural Municipality Gulmi Nepal.

Bid validity must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum as mentioned in table above which shall be valid for minimum 90 days beyond the bid validity period. The scanned copy of bid security should be uploaded in the system during bid submission.

If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

Bid meeting shall be held on 29-01-2020 14:00 hours at Office of Chandrakot Rural Municipality. Any person, firm or company blacklisted as per Public Procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.

Other matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulation-2064 with amendment and other prevailing regulation.
